SOUTHERN NEW MEXICO STATE FAIR AND RODEO QUEENS CONTRACT

This contract and agreement is entered into by and between the Southern New Mexico State Fair and Rodeo Queens Committee ("the Committee") and the Contestant.

WHEREAS the contestant is desirous of representing the Southern New Mexico State Fair and Rodeo, and

WHEREAS the Committee is desirous of having said contestant represent her title at various events around Southern New Mexico, it is hereby agreed that:

- 1. The Contestant understands that by signing The Southern New Mexico State Fair and Rodeo Queens Contract, The Southern New Mexico State Fair and Rodeo Queens Expectation Statement, Participation Statement and Code of Conduct, that she is committing herself to Southern New Mexico State Fair and Rodeo Queens Court. This is to include one (1) year as the titleholder. During this entire period, she shall conduct herself with dignity and ethical behavior befitting the title. She understands that she will be living in the public eye for this period of time and will be a role model. She should always be properly attired at all times, to include "off time", and must conduct herself in a processional and moral manner at all public events, including social media websites.
- 2. The committee shall furnish a crown, buckle, sash and other awards as is feasible, but shall offer NO form of financial assistance, nor will it assume financial responsibility for reimbursement to contestant for any expenses incurred by her during her reign. The furnished crown will be handed down at the end of her reign to the next year's contestant. The contestant understands and agrees that if she loses or damages the crown she will be financially responsible to replace the damaged or lost crown.
- 3. The contestant is required and agrees to attend events, including but not limited to the following:
 - Southern New Mexico State Fair and Rodeo Events
 - The Hatch Green Chile Festival Parade
 - Local parades to be determined by the Committee
 - The 2020 Pageant Orientation, Rehearsal and Pageant
 - Any other events as requested by the committee
- 4. It is agreed that the Contestant will be allowed three (3) authorized excusals during her reign. The Committee has the discretion to determine authorized or unauthorized excusals. Examples of authorized excusals include 4-H and FFA events that conflict with the committee's schedule.
- 5. It is agreed that should the Contestant fail to attend the required events or fulfill the duties of the Southern New Mexico State Fair and Rodeo, bring embarrassment or negative attention to the Committee or the Southern New Mexico State Fair, she shall be in danger of

losing her title and any prizes awarded thereof. The Contestant will be offered one warning for any disciplinary action or breach of contract. If the Contestant receives a second disciplinary action or breach of contract, she shall forfeit her title, crown, sash and buckle to the committee immediately.
